REQUIREMENTS: My dog meets the following Boarding requirements and he/she: has successfully completed the Behavioral Interview; is ten (10) weeks of age or older; he/she is spayed or neutered (if over six (6) months of age); is current on his/her Rabies, Distemper and Bordetella vaccinations; is in good general health and free of ticks and fleas; is not aggressive or protective of toys; meets all other municipal or state licensure and other requirements; is attending Daycare/Boarding with a collar that contains an identification tag bearing the name and guardian or owner's current contact information. My dog will enter and exit the facility with a leash.

PERSONAL PROPERTY. I agree that Furry Kids BB & T shall not be responsible or liable for any lost, stolen or damaged personal property belonging either to me or my dog. I also understand and agree that my dog's collar may be removed in the play area to prevent injury to any dog. If my dog causes any damage to the facilities or equipment, I agree to be fully responsible for the full cost of any repair or replacement.

FEES. I agree to pay for all fees, services and products by cash or check. A \$50 deposit is required at time of booking for boarding services. Refundable if boarding is cancelled 2 weeks prior to date boarding was to begin. If no change in boarding services, deposit is applied towards total amount due. Balance of payment for boarding services is due prior to or at drop off. I further agree to pay the cost of any check returned.

AGGRESSIVE DOGS. My dog is not aggressive, I understand that aggressive dogs are not permitted to attend Boarding and that if my dog acts aggressively or exhibits unacceptable behavior he/she may be separated from the other dogs. Furry Kids BB & T will use reasonable efforts to consult dog's parents about aggression and ways to address it, however aggressive dogs may be asked not to return. Such determinations shall be made at the sole discretion of Furry Kids BB & T.

ABANDONED DOGS. No dog may be abandoned at Furry Kids BB & T. I agree that I will not neglect to pick up my dog by the time he/she is scheduled to leave without providing notification. Any dog that is left at Furry Kids BB & T without any contact, instruction or notification from me, of the ability, willingness or plans to pick him/her up by myself or my personal representative or agent, will be considered abandoned upon the seventh day of such notification failure. I understand that if I abandon my dog, Furry Kids BB & T will, by default, become the legal owner and guardian of the dog and in its sole discretion, will determine whether to try to rehome and adopt the dog from the location at which he/she was abandoned or will relinquish the dog to an unrelated shelter of its choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT FURRY KIDS BB & T, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST FURRY KIDS BB & T AS PROVIDED FOR BELOW

DUTY TO DISCLOSE. I have disclosed and shall continue to disclose on an on going basis, any and all medical or other conditions, including but not limited to personality concerns or behaviors that may affect, limit or prevent my dog's ability to participate in play time or otherwise attend daycare/boarding.

ACCEPTANCE AND ACKNOWLEDGEMENT OF BOARDING PARTICIPATION RISK. I FULLY UNDERSTAND THAT: (a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN DOGS AND OTHER DOGS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR DOG; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO ME NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY, "RISKS"). I FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF MY OR MY DOGS'S PARTICIPATION IN BOARDING INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF MY DOG. SICKNESS SHALL BE DEFINED TO INCLUDE ANY ILLNESS INCLUDING BUT NOT LIMITED TO BORDETELLA (KENNEL COUGH) OR ANY OTHER FORM OF CONTAGIOUS ILLNESS.

VETERINARIAN LIABILITY AND CARE. I agree to allow Furry Kids BB & T. to obtain medical treatment for my dog, if, in its sole discretion it appears that, he/she is ill, injured or exhibits any other behavior that would reasonably suggest need for medical treatment. If a dog passes away at the facility, it will be brought to its or the nearest veterinarian. I AGREE THAT I AM FULLY RESPONSIBLE FOR THE COST OF ANY SUCH MEDICAL TREATMENT, AND FOR THE COST OF ANY TRANSPORTATION FOR THE PURPOSES OF SUCH TREATMENT, PROVIDED TO MY DOG.

WAIVER, RELEASE AND INDEMNIFICATION. I HEREBY EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND AND COVENANT NOT TO USE Furry Kids BB & T., and their invitees, sponsors, advertisers, owners, officers, directors, employees, volunteers, invitees, agents, lessors, and any parties owning, controlling or having any interest in the property at which the Event is taking place, and all other representatives or agents (the "Releasees") from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, EXPENSES OR DEMANDS (including reasonable attorney's fees) OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releasees, including negligence, and (ii) my or my dog's participation in activities at Furry Kids BB& T; or otherwise. I FURTHER AGREE TO INDEMNIFY, SAVE AND HOLD HARMLESS the Releasees from any claims, litigation, actions, suits, damages, costs, attorney's fees, losses or injuries as the result of any such claim. I AGREE THAT THIS RELEASE SHALL BE BINDING ON ME AND MY SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. I ALSO EXPRESSLY AND FOREVER RELEASE Furry Kids BB & T FROM ANY DUTY TO PROTECT ME OR MY DOG(S) FROM INJURY OF ANY KIND, AND AGREE THAT EVEN IF Furry Kids BB & T CHOOSE TO IMPLEMENT SAFETY PRECAUTIONS, SUCH ACTIONS SHALL NOT ALTER THE FACT THAT I HAVE RELEASED Furry Kids BB & T FROM ANY DUTY TO PROTECT ME OR MY DOG(S).

I HAVE READ AND FULLY UNDERSTAND THE TERMS OF THE POLICIES, PROCEDURES AND RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" (THE "AGREEMENT") AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT PERMITTED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID OR UNENFORCEABLE, THAT THE REMAINDER OF THIS AGREEMENT SHALL REMAIN IN FULL FORCE AND EFFECT. I AGREE THAT IT IS INTENDED THAT ALL TERMS OF THIS AGREEMENT CONTROL DESPITE ANY PARTICULAR STATUTE OR LAW THAT WOULD OTHERWISE PROTECT ME OR MY DOG(S).
